# **TECHNICAL SPECIFICATION**

## **SOLUTION REQUIREMENTS**

Limpopo Tourism Agency (LTA) is looking for the services of a reputable and experienced service provider with a proven track record to provide them with modernised application solution with a continuous available, SaaS that meets their service reliability and uptime needs.

LTA wishes to make use of the following services on O365;

- Office applications,
- Exchange Online,
- Teams and SharePoint.

The appointed service provider will be expected to provide 70 x O365 Enterprise E3 licenses, facilitate Planning, Administration and Migration of data from the current dedicated exchange environment including, but not limited to the following;

- migrate user e-mails from the on-premises Microsoft Exchange Server to Microsoft Exchange Online and archiving
- setup Microsoft Teams for all the users
- configure One Drive for user data backup purposes
- setup Microsoft Office 365 Enterprise E3 Apps
- setup a Microsoft SharePoint Online for document management

## **CURRENT ENVIRONMENT**

The Limpopo Tourism Agency has a head office in Polokwane with other regional offices in the Limpopo province. All offices have a direct connection to the Internet. However, Limpopo Tourism Agency does not have a tenant on Office 365,

Active Directory has been deployed and hosts approximately 70 user accounts as well as a single Exchange Server.

Workstations for users that are located in the head office are joined to Active Directory and mostly versions of Microsoft Windows 10 and Microsoft Office 2010 are in the environment.

The mail platform consists of a single Microsoft Exchange server. Outgoing email is relayed to destination mail servers via the Mime Cast mail hygiene solution. Connectivity to the Internet is provided through a primary dedicated internet access.

## 1. EVALUATION METHODOLOGY

- (d) “**Broad-Based Black Economic Empowerment Act**” means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
