## **SPECIFICATIONS:**

### **SCOPE OF WORK**

The LTA hereby requests a proposal for an electronic Board meeting solution.

The LTA requires access for 15 users (made up of 7 Board Members, 4 Executives, 2 administrators from the Company Secretariat and 2 technicians from the ICT unit). The Board meeting solution should be able to fully facilitate the electronic distribution of Board meeting packs to official LTA handheld devices. The solution should also be able to ease the logistics of compiling the packs and improve overall governance within the LTA.

**As a minimum, the LTA expects the solution to possess the following functionalities:**

- The system should be securely accessible by all board members from any location and should support strong security features such as encryption or two-phase authentications; The system must be capable of providing enhanced security tools like remote locking;
- The system should cater for users on mobile platforms and should also support most modern web browsers;
- The system should allow for seamless scheduling of meetings with an online, collaborative meeting space where you can include venue maps; agendas; attendee list; meeting minutes; pre-and post-meeting actions and add related documents;
- The solution should provide for a meeting pack function which allows one to easily collate meeting documents, including agendas, index, minutes, dividers and page numbering, into one file. Board members should be able to perform annotations (highlight text, make notes etc.) and document sign off on their meeting packs, complete questionnaires, ask questions, place votes with or without Wi-Fi;
- The solution should provide an intuitive and functionally rich knowledge store;
- The solution should provide a centralised, collaborative platform where everyone can access and contribute to good decision making by capturing all decisions made and allowing easy to create surveys;
- Extensive end-user as well as administrator training on the use of the system;
- The system should allow creation and distribution of resolutions for voting by Board members and tracking thereof;
- The system should allow Board members to use its functions and content both online and offline and provide Board members with full access to minutes and resolutions;
- Proposals on the setup and configuration of the system on the LTA premises;
- Customizable permissions for data access can be personalized down to the document-level and user-level to improve privacy and security;
- The system should have the ability to create virtual rooms for board committees or smaller groups to allow secure collaboration before and after meetings; and

- The solution should have minute taking capabilities to enhance minute taking processes.

The supplier has the primary responsibility to ensure that quantity and quality are in accordance with the specification.

## EVALUATION METHODOLOGY

In accordance with the Preferential Procurement Regulations, 2017, the bid evaluation process shall be carried out in three Phases namely:

- Phase 1 : Administrative Compliance
- Phase 2 : Evaluation on Functionality
- Phase 3 : Evaluation in terms of Price and Preference Point Systems

**1. Phase 1: Administrative Compliance** (Submission of compulsory proposal requirements by bidders and compliance to specification.)

The first phase of evaluation is checking and verification of all mandatory documents to be submitted by the bidders and compliance to specification.

Bidders are required to comply with the bidder requirements mentioned above.

Certified copies or original documents will be accepted.

Bidders that do not comply with the bid requirements may be regarded as non-responsive and may be disqualified.

**2. Phase 2: Evaluation on Functionality and Technical Specifications**

The assessment on functionality will be done in terms of the evaluation criteria and minimum threshold as specified. The minimum qualifying score for functionality is **60%** as set out below. Bidders who fail to achieve the minimum qualifying score on functionality will be disqualified for further evaluation of price and B-BBEE status.

The minimum qualifying score for functionality is **60%**.

### 3. Phase 3 : Evaluation in terms of Price and Preference Point Systems

Only bids that achieve the minimum qualifying score/percentage for functionality will be evaluated further in accordance with the 80/20 preference point system prescribe in Preferential Procurement Regulations 6 and 7.

#### Step 1: Calculation of Points for Price

- 1) The PPPFA prescribes that the lowest acceptable bid will score 80 points for price. Bidders that quoted higher prices will score lower points for price on a pro-rata basis.
- 2) **When calculating prices:**
  - a) Unconditional discounts will be taken into account for evaluation purposes; and
  - b) Conditional discounts will not be taken into account for evaluation purposes but would be implemented when payment is affected.
