APPOINTMENT OF A CREATIVE AGENCY TO IMPLEMENT SHORT-TERM MARKETING CAMPAIGN FOR LIMPOPO FROM SEPT TO DEC 2020

1. *INVITATION*

1.1 Limpopo Tourism Agency (LTA) requires services of an experienced creative agency to assist with development of an effective short-term (**3 months**) marketing campaign as part of LTA's COVID-19 recovery plan.

2. *DELIVERABLES / KEY PERFORMANCE AREAS*

- LTA is looking for a creative agency to develop a marketing campaign to stimulate domestic tourism and position destination Limpopo as a destination to visit when the sector reopens following the COVID-19 pandemic. Agency will be required to:
 - Develop a creative concept (campaign idea/theme) that will roll out on all campaign elements;
 - Develop a creative marketing campaign for COVID-19 targeting LSM 4-6 and LSM 6 - 8 from Limpopo's key domestic tourism source markets as well Limpopians)
 - Produce a short promotional video suitable for various digital media platforms and television; the video must highlight diverse experiences available in the province and must also include one on LWR experiences
 - Developing a copy for radio advertisements aimed mainly at domestic market (executions in English and indigenous languages, covering experiences in 5 regions and incl. Limpopo Wildlife Resorts)

- Developing print advertisement execution, digital flyers, digital banners as well as promotional broadsheet for travel packages;
- Identifying and managing 10 social media influencers that will be used for the campaign
- Drafting a close-out report for the campaign

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
