**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.

4. The entity is an empowering supplier in terms of the **dti** Codes of Good Practice.
